## **EU policy updates**

#### **Commission launches AI in Science Strategy**

Across the globe, countries are competing to unlock and capitalise on the potential of Artificial Intelligence (AI). On 8 October 2025, the European Commission launched the <u>AI in Science Strategy</u>. At its core is RAISE (Resource for AI Science in Europe), a virtual institute intended to coordinate AI resources for scientific development. Key actions include:

- Attracting AI talent, for example through <u>Networks of Excellence</u> and Doctoral Networks on AI (RAISE pilot using the MSCA Doctoral Networks model).
- Boosting computational power and ensuring access to AI Gigafactories.
- Increasing Horizon Europe's investment in Al.
- Identifying data gaps and building high-quality datasets.

In addition to the AI in Science Strategy, the Commission has introduced the <u>Apply AI Strategy</u>, which aims to promote the adoption of AI across strategic and public sectors to harness its potential.

#### **New EU Bioeconomy Strategy**

On 27 November 2025, the European Commission presented a new bioeconomy strategy to scale up innovation and investment, establish new lead markets for bio-based materials and technologies, ensure sustainable biomass supply along value chains, and position the EU as a global player in the bioeconomy. Among other measures, funding for the bioeconomy shall be increased in the next Multiannual Financial Framework (MFF 2028–2034) through the European Competitiveness Fund (ECF) and the policy window on health, biotechnology, agriculture, and bioeconomy in the Horizon Europe Framework Programme. #### New ERC funding instrument announced: ERC Plus Grants

For the 2026 Work Programme, the European Research Council (ERC) has announced a new funding instrument: the "super grants" **ERC Plus**. This new funding scheme will be introduced to support outstanding principal investigators with bold ideas and a vision for **transformative research that goes beyond the scope of existing ERC programmes**. This means that the ability to demonstrate a project's transformative potential will be considered to be just as important as the underlying scientific excellence.

The competition will be open to researchers of any nationality and career stage who apply with a host institution in an EU Member State or a Horizon Europe associated country. With funding of €7 million (lump sum) for the duration of 4–7 years, around 30 grants will be available. The opening of the call is planned for June 2026, with the application deadline set for the beginning of September 2026. Evaluation results are expected in early 2027.

The ERC is currently finalising the details of this new scheme, which are expected to be published by the end of 2025 in the form of an amendment to the 2026 Work Programme.

#### **MSCA** news

#### **Discover the new MSCA Public Dashboard**

The Marie Skłodowska-Curie Actions (MSCA) have launched the MSCA Public Dashboard. This interactive platform offers access to detailed data on MSCA-funded projects. It includes interactive maps, statistics and visualizations that present different aspects of the MSCA, offering an overview of funded projects and insight into the programme's evolution over time.

#### Preliminary MSCA Work Programme for 2026–2027 published

The European Commission has published the preliminary Work Programme for the Marie Skłodowska-Curie Actions for the 2026 and 2027 calls. In addition to budgetary changes compared to the previous work programme, various content-related adjustments have also been made. For example, **new rules for secondments** now apply to Postdoctoral Fellowships, Doctoral Networks, and Cofund. Secondments are now possible for half of the total fellowship duration (for global fellowships, this applies to the outgoing phase). **Resubmission of Doctoral Networks and Postdoctoral Fellowships applications will require a threshold score of 80% in future**. Furthermore, the living and top-up allowances as well as the country correction coefficients will be aligned with current inflation.

#### **New EIC Work Programme adopted**

The European Commission has adopted the 2026 EIC Work Programme, providing €1.4 billion to support breakthrough and deep-tech innovation. The updated programme introduces Advanced Innovation Challenges to speed up the commercialisation of high-risk research in strategic areas. Preparations also continue for the Scaleup Europe Fund, aimed at improving access to late-stage growth capital for deep-tech scale-ups.

The EIC Accelerator will see a simplified application process, with full proposals reduced to 20 pages and evaluations held every two months. A clearer assessment of technology readiness will further support faster and more efficient funding decisions.

### **Association of Third Countries to Horizon Europe**

On 22 October 2025, **Egypt** officially joined Horizon Europe, becoming the second African country, after Tunisia, to be associated with the Research and Innovation Framework Programme. The association enables Egyptian researchers and organizations to **participate in all areas of the programme under the same conditions as <b>EU Member States**. **Switzerland** has also **officially joined Horizon Europe**, along with the Digital Europe and Euroatom funding programmes. The agreement between the EU and Switzerland was signed on 10 November 2025, **taking effect retroactively from 1 January 2025**. Furthermore, Switzerland's association to Erasmus+ is planned for 2027. You can find more detailed information <u>here</u>.

The EU and **Japan** are committed to conclude negotiations on <u>Japan's association to Horizon Europe</u>. This would allow organizations based in Japan to participate as beneficiaries and receive EU funding from the 2026–2027 Work Programme onwards. The association will be limited to Pillar II of Horizon Europe ("Global Challenges & European Industrial Competitiveness").

Furthermore, the European Commission and the **Australian Government** have started <u>exploratory talks on a possible association of Australia to Horizon Europe</u>.
