Founded in 1872, Sciences Po is France's leading university in the social sciences. For over 140 years, Sciences Po has educated decision-makers in the public and private sectors. Our College offers a three-year undergraduate degree that includes a year abroad at one of 470 partner universities. There are seven graduate schools composed of 30 master's degrees and five PhD programmes.

Sciences Po hosts 42 dual degrees with partner universities, including Columbia University in New York, the London School of Economics and Peking University. We also provide executive education with 14 dedicated executive master's degrees and over 100 customised training programmes.

Sciences Po offers a multidisciplinary, multilingual and outward looking education. In order to provide a comprehensive curriculum, Sciences Po places great emphasis on fundamental academic courses, professional training and extra-curricular activities. Sciences Po also integrates digital teaching methods into its programmes and continues to develop innovative teaching platforms, such as MOOCs.







UNDERGRADUATE STUDIES

The Bachelor of Arts at Sciences Po

A multidisciplinary foundation in the humanities and social sciences

Sciences Po offers a three-year Bachelor of Arts degree with a multidisciplinary foundation in the humanities and social sciences and an emphasis on civic, linguistic, artistic, and digital education.

The Bachelor of Arts pursues three core ambitions:

- Teaching to understand a complex world.
- Providing students with methods adapted to respond to diverse challenges.
- Instilling in students a sense of duty to contribute to their society.

Choice of major and geographical concentration

On all campuses, students choose a multidisciplinary major – Economy & Society, Political Humanities, or Politics & Government. In addition, each campus offers a different regional concentration that anchors students' intellectual objectives: Africa, Asia, Europe, Latin America, Middle East-Mediterranean, and North America.

Focus on the Political Humanities

Sciences Po's undergraduate curriculum emphasises the study of the humanities. Fields such as art history, geography, literature, and philosophy are paramount to cultivating a critical analysis of contemporary political, economic and social questions.



A progressive and international curriculum

Two years in France and one year abroad

Undergraduates spend their first two years on a Sciences Po campus before pursuing their third and final year at one of Sciences Po's 470 partner universities. This international academic experience may be complemented by an internship. The degree culminates with a capstone project.

First year: Learning the fundamentals

On each of the campuses, undergraduate students are introduced to the disciplines and methods taught at Sciences Po – economics, history, humanities, law, political science, and sociology. Certain courses are related to the regional concentrations offered on each campus.

Second year: Acquiring intellectual autonomy

Students choose a major – Economy & Society, Political Humanities, or Politics & Government –, explore a range of multidisciplinary courses, and interact with the research methodologies linked to their chosen major.

Third year: Expanding one's academic project

During their year abroad, undergraduates complete their major at a partner university.

A civic learning programme

All undergraduate students engage in civic coursework and practical experience during each of the three years of the Bachelor's programme. The civic learning programme emphasises autonomy, consensus building, and developing a personal ethic of responsibility.

One degree, countless opportunities

Upon completion of the BA, students are equipped to pursue graduate studies at one of Sciences Po's seven graduate schools or at any of the world's most competitive universities. Common fields of study include communication, economics, finance, international affairs, journalism, law, organisational behaviour, and public affairs.

Dual Bachelor's Degrees

Two years at Sciences Po + two years at the partner university

Sciences Po offers dual Bachelor's degrees with nine of the world's leading universities, allowing students to study as fully-integrated members of two distinct academic cultures. Students from all around the world are recruited jointly by both institutions and form close-knit cohorts that are fully-integrated into the larger communities of their two universities.

The first two years of all dual Bachelor's programmes take place on one of Sciences Po's campuses, where participants pursue the undergraduate curriculum and their choice of major. In years 3 and 4 at the partner university, students pursue a major offered by the host institution. Upon successful completion of the two curricula, students graduate with two Bachelor's degrees, offering exceptional access to prestigious graduate studies or to entry into the job market.



Sciences Po Exchange Programme

Each year, Sciences Po welcomes more than 1,500 undergraduate and graduate students from its partner university network. For either one semester or a full year, exchange students take classes in French, English, or in both languages. The exchange programme is an excellent opportunity to discover Sciences Po's internationally-focused and professionally-relevant social science curriculum, distinctive teaching methods, and vibrant student life.



For undergraduate studies, exchange students choose from among Sciences Po's seven campuses: Dijon, Le Havre, Menton, Nancy, Paris, Poitiers, or Reims. Sciences Po offers a large choice of courses within its multidisciplinary programme in the humanities and social sciences. At the graduate and postgraduate levels, all studies take place on the Paris campus. They integrate one of Sciences Po's seven graduate schools, each of which allows the possibility to combine study with professional practice.

GRADUATE STUDIES

Rigorous academic study and insight into professional practice

At the graduate level, Sciences Po's seven schools offer one- and two-year Master's programmes and PhD programmes. All graduate programmes are delivered on the Sciences Po campus in Paris.

Sciences Po also hosts dual Master's programmes with international partners. Students enrolled in these dual degree programmes spend one year at Sciences Po in Paris and one year at the partner university.

Two-year Master's programmes

are open to students with a degree from a foreign higher education institution. The curriculum combines academic theory and analysis with practical, applied project work. Each programme has four 12-week semesters. One semester is spent completing an internship abroad or studying at a Sciences Po partner university. Programmes are taught in French or English; some require both languages.

One-year Master's programmes

deliver an intensive curriculum designed for young professionals who want to develop the expertise necessary to accelerate their careers. All the programmes are taught in English.

PhD programmes

offer solid training in research. Students study for their PhD in one of Sciences Po's 11 research centres.





SUMMER SCHOOL

Two programmes, one unforgettable summer

The Summer School is an opportunity for students from all over the world to discover Sciences Po over the course of the summer. Participants have the opportunity to experience Sciences Po's academic environment and to become a part of its international community. It features two distinct programmes: the University Programme, for university students and graduates, and the Pre-College Programme, for secondary school students.

The University Programme takes place on the Paris campus in two separate, four-week sessions during the months of June and July. Through its intensive academic programme, participants may delve into Sciences Po's core social sciences disciplines, study French language and culture, or mix both subjects.

In 2017, the Pre-College Programme introduced secondary students to student life and academics at Sciences Po during two weeks on its historic Reims campus. Through challenging coursework that combined social sciences and language study, students got a taste of the Sciences Po experience.

RESEARCH AT SCIENCES PO

Research conducted at Sciences Po focuses on the governance of contemporary societies. The idea is to understand political and economic phenomena and their impact on societies in terms of stratification, diversification and inequalities. The study of society and governance is advanced through five disciplines: law, economics, history, political science and sociology. Research projects cover all the countries of the world, and are often comparative.

Research-led teaching at the Doctoral School

The Doctoral School offers research-based Master's programmes and PhD programmes in law, economics, history, political science and sociology.

Master's programmes

Research Master's cohorts are limited to 20 or 30 students, which means they benefit from continued individual supervision. Courses are delivered by academics from Sciences Po research centres. The first year is devoted to theory courses, an introduction to research, and to choosing a subject for the research dissertation. The dissertation is a key component of the research Master's programmes and accounts for a quarter of the ECTS credits. Students spend much of the second year, the second semester especially, on preparing and writing their dissertation.

Doctoral training

PhD students at Sciences Po are enrolled in one of the Doctoral School's discipline-specific programmes and also belong to a research centre, of which they are considered full members. During their training. PhD students can participate in international exchange programmes, including two- to three-month research exchanges with Cambridge, Oxford, the London School of Economics and the National University of Singapore. The Doctoral School also offers oneyear exchanges with several American universities including UC Berkeley, Columbia University, Harvard and Northwestern

Dual Master's and dual PhD degrees

Dual Master's degree programmes are offered with Sorbonne University, the École du Louvre and Inalco in France, and Keio University in Japan. Dual PhD programmes are offered with Columbia University and Northwestern University in the United States, and the International Max Planck Research School and the University of Cologne in Germany.

Financial aid

PhD students can benefit from mobility funding, funding for publication costs or doctoral scholarships of €16,400 per year for three years. Sciences Po also offers doctoral contracts for a period of three years. These contracts offer a gross monthly salary of €1,758, for research activities only. Doctoral scholarships and doctoral contracts are awarded on the basis of merit.

Career prospects

Several careers seminars and workshops are organised to help Master's and PhD students achieve their career goals. Graduates of the Sciences Po Doctoral School are recruited every year to research or teaching positions. Doctoral School graduates also take up positions of responsibility in a wide range of organisations: consulting firms, non-profits, public administration, local authorities, NGOs, international organisations, private companies, etc.

ADMISSIONS

How to apply?

Undergraduates

International undergraduate admissions – for students who obtained a foreign secondary school diploma or a French baccalaureate abroad – are based on the evaluation of an online application, followed by an interview for short-listed applicants. Interviews take place in more than 70 cities across the world.

Graduates

International graduate admissions – for students who have completed their undergraduate or graduate education outside of France – are based on the evaluation of an online application.

Tuition fees

- > Students whose tax residence is in the European Economic Area pay tuition on a sliding scale, from €0 to €10,250* per year for undergraduate programmes and from €0 to €14,100* for graduate programmes. Tuition is determined by family income and household size.
- > Students whose tax residence is not in the European Economic Area pay €10,250* per year for the undergraduate programme and €14,100* per year for graduate programmes.

Financial aid & scholarships

Several financial aid and scholarship programmes are available. Non-European students are eligible for:

- Sciences Po Boutmy scholarships for both undergraduate and graduate programmes
- Eiffel scholarships for graduate programmes, funded by the French government
