



## Universitätsgesellschaft Potsdam e.V. announces “Inklusionspreis“

The Universitätsgesellschaft Potsdam e.V. together with the Koordinationsbüro für Chancengleichheit, the commissioner for employees with disabilities and the commissioner for students with disabilities and chronic illnesses award the “Inklusionspreis” in 2021 for the third time. The prize is endowed with 500,00 EUR and will be awarded by the Universitätsgesellschaft Potsdam e.V. in cooperation with the Barmer fund.

### The “Inclusion Prize“ honors persons or initiatives at the University of Potsdam,

- who support the dismantling of discrimination (**intervention**), the expansion and strengthening of discrimination protection (**prevention**), the visibility and thematization of **diversity and discrimination**, and the **empowerment and/or networking initiatives** at the University of Potsdam.
- who show a **particular stance against discrimination** at the University of Potsdam or enforce outstandingly inclusive/diverse **courses**.
- who conceptualize and conduct diverse and relevant **research projects**.

### The inclusion insight:

The University of Potsdam represent the inclusion insight according to their inclusion concept of March 17<sup>th</sup>, 2021. Moreover, many other diversity areas are included. The focus here lies on marginalized groups who are discriminated against because of one or more features (disability, state of health, social upbringing, gender, social status, (ascribed) cultural and religious background, sexual orientation, background or racist attributions, nationality/citizenship, language, appearance, civil status, reproduction and custody matters).

### The application and selection process:

Members and Alumni of the University of Potsdam can suggest persons or initiatives. The suggestion is done informally. The declaration should not exceed more than two pages. The explanation should make note of the aforementioned criteria. A selection committee<sup>1</sup> decides
