### Purpose of the processing

Please note that, unfortunately, the nomination cannot be considered without consent being granted for the data processing associated with the implementation of the nomination procedure.

## Withdrawal of consent

You have the right to withdraw your consent at any time and without reason. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

## **Duration of data processing**

Your data will be stored during the preparation of the jury meeting and the jury session from the receipt of your nomination until the awarding of the prize by January of the respective year.
