

Formal requirements for deposit copies

The number and form of deposit copies depend on the specific requirements of the faculties. The text version of the deposit copies needs to be identical with the version that was approved by your faculty. Should the submitted version of your thesis contain personal data, it may be deleted from the online/print version.

Requirements for printouts

- white copy paper (at least 80 g/m²) in DIN A4 format
- permanent binding, i.e. glue, thermal or velo binding, **no ring binding**
- one-/two-sided printing
- graphics and images in black and white, unless they need to be printed in color for content reasons

Front Cover

- author • title • thesis type • faculty
- institute or non-university institution
- academic degree • academic discipline
- date of disputation

Front Cover backside

- supervisor/s
- reviewer/s

Requirements for published books

If your thesis was published by a professional publisher, you need to submit deposit copies of the published book.

Publication note/Hochschulschriftenvermerk

The imprint of your published thesis should contain a note which identifies it as a Potsdam University publication. Please specify a thesis type (dissertation or habilitation thesis), the institution that awarded the degree title, as well as the year in which the title was awarded.

Example: Dissertation, Universität Potsdam, 2022

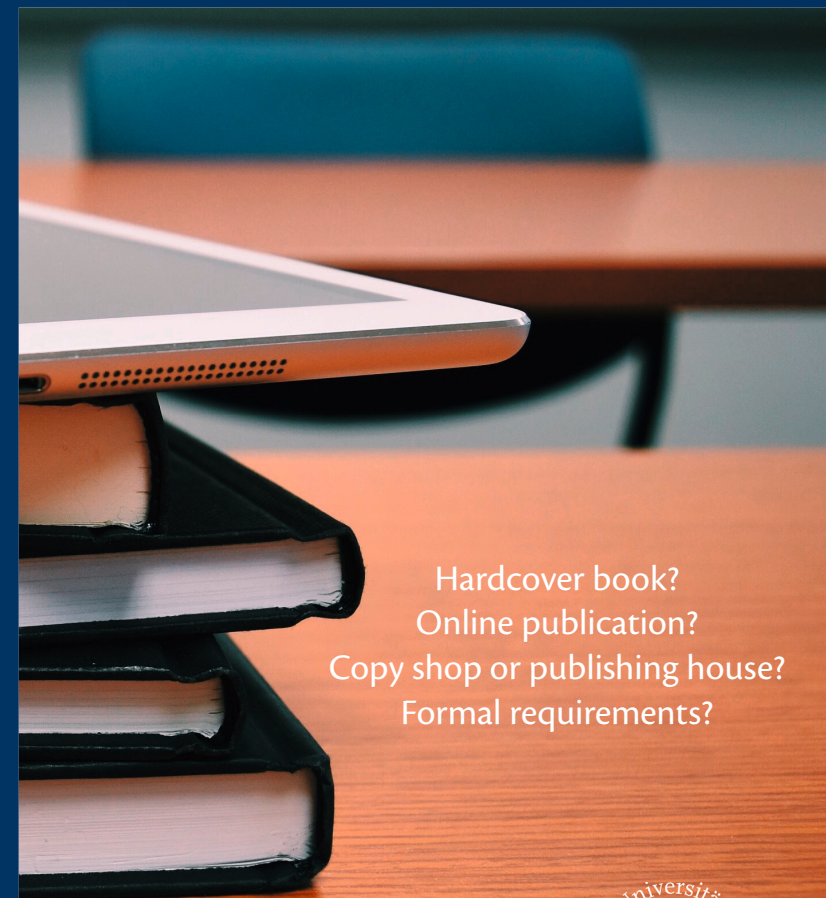

Submit Deposit Copies

The doctoral degree regulations (Promotionsordnungen) of Potsdam University and the post-doctoral degree regulation (Habilitationsordnung) of the Faculty of Science and the Digital Engineering Faculty stipulate the publication of dissertations and habilitation theses as well as the submission of deposit copies.

Online or print publication?

Dissertations and habilitation theses may be published online on the publication server of Potsdam University or in print. Deposit copies are required in both cases. Please note: The digital version of your thesis needs to be identical with the text version of the submitted print copies.

If you wish to publish a publication-based thesis on our publication server, the secondary publication right for your thesis needs to be clarified beforehand. For detailed information, refer to <https://www.ub.uni-potsdam.de/en/publishing/open-access/secondary-publication-author-rights>



Online publication

You can reduce the number of deposit copies by publishing your thesis open access. This publishing method is particularly cost-effective and ensures permanent accessibility of your work.

Publishing online on our publication server:

1. Click “Submit“ and enter your data.
2. Upload the PDF version of your work, as well as the files in their original format (Word, LaTeX etc.).
3. Tick “Add to bibliography?“.
4. Subsequently, we add an imprint page to the document and send it back to you for printing. Please use this version only to print your deposit copies and read our formal requirements for deposit copies beforehand.

Print publication

If you opt for a traditional print publication (copy shop or commercial publisher) the number of deposit copies to be handed in will be much higher than the number of copies required for online publications.

Outstanding dissertations or habilitation theses may also be published in parallel as print publication and open access e-book with Universitätsverlag Potsdam (University Press). In this case, you do not need to submit additional deposit copies.
